Educational Scholarship Program Funding Guidelines and Reporting Requirements

Pied Piper is committed to providing access to the performing arts to children. It is our desire that no child be denied the opportunity to partake of this enriching educational experience because of financial need. To that end, we are proud to offer educational scholarships to children who have a demonstrated need.

Please review the guidelines and requirements below prior to completing the application. The priority deadline for the upcoming season's scholarship applications is available on our website. Requests after this date will be granted based on availability of funds. Please take this timeline into account and plan your application submission accordingly. For the best consideration of your request, we encourage you to apply for scholarship funding as early as possible.

FUNDING GUIDELINES:

- **Scholarships must be used to cover each qualifying student's full admission cost.** Scholarship funds should not be applied toward the admission cost of non-qualifying students or adult chaperones.
- Scholarships are allocated based on your schools' overall free/reduced lunch percentage.
- To qualify for PP Scholarship funding, child(ren) **must** be a recipient of free or reduced-price lunch under the Federal Hot Lunch Program (FHLP).
- Child(ren) may only receive PP Scholarship funding **once per school year**.

REPORTING REQUIREMENTS:

- Educator must provide a school district-generated letter or report, which documents the percentages of children in the educator's school that qualify for free and reduced-price lunch under the Federal School Lunch Program.
- Educator must complete an online survey, provided by Pied Piper, subsequent to his or her class's attendance of the performance.
- Pied Piper Presents requests that the educator submit documentation created by the students who attend the performance, which may include, but is not limited to a writing project, a visual arts project, or an audio-visual presentation, that is related in some way to their experience. **PLEASE** be creative. **Photos are great!** This helps us demonstrate to funders and potential funders that the experience was valuable, educational and was related to work being done in the classroom. All submitted artwork will become the property of Pied Piper; because of this, we are happy to accept copies in place of the originals.
